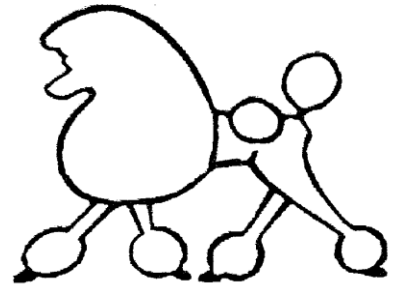

Sales Contract

Every precaution has been taken to see that your puppy is happy and healthy. You are urged to take your puppy to your veterinarian within 72 hours of the date of sell. If your puppy is found unsound, you may return your puppy within 72 hours written Assessment from said veterinarian stating in what respect the puppy is unsound. The puppy will be replaced at the earliest availability with a pet of equal or superior quality. NO guarantee is made as to size or color. The breeder will NOT be responsible for any expenses incurred by purchaser. After 72 hours the breeder is in no way obligated to take back this puppy. The dog will be guaranteed to pass hips, eyes and skin at 2 years of age IF the purchaser follows breeders and Dr Jean Dodds minimum shot protocol, which is as follows: Nobivac Puppy- DPv ONLY 3 to 4 shots throughout 8 to 16 weeks and wait 3 to 4 weeks to give Rabies, a booster at 1 year of Nobivac Parvo/Distemper and Rabies 3 to 4 weeks after, and NO OTHER shots for the life of the dog unless a titer ran by Dr Jean Dodds lab shows lack of immunity. If dog does not pass then a replacement will be offered. If it is found that the purchaser is responsible for the dog NOT passing any of the above, then no replacement shall be warranted. (ex. Purchaser takes puppy jogging at too young of age.) Breeder requires purchaser to maintain the puppy on NuVet supplements for at least 2 years, preferably the life of the dog for a lifetime warranty.

Purchaser agrees to have pet groomed on a regular basis by a professional groomer on the average of every 3 to 6 weeks, 8 weeks being the maximum. Purchaser agrees to keep pet on a heartworm preventative as recommended by their veterinarian. Purchaser agrees to keep pet indoors and never left in the backyard for extended periods of time, this is NOT an outside pet.

This contract is NOT transferable to another owner. In the event that you do not want this dog, the breeder MUST BE NOTIFIED and approve of the new owner. The breeder has the first right of refusal of this dog. You can NOT sell, trade or give Away your pet without the written consent of Angie Killian. It is NEVER to be taken to a animal shelter or pound of ANY Kind, it is to be returned to Angie Killian.

This pet is sold with limited registration, which means that this pet can NOT be breed at any time without the written consent of Angie Killian. Breeding this pet without the knowledge and consent of Angie Killian will result in a fine payable to Angie Killian of Argan Poodles in the amount of \$10,000.00 ten thousand dollars for breach of contract and for miscellaneous damages. It is agreed by both parties that this pet will be neutered or spayed at 8 to 9 months of age after the growth plate has closed, and breeder also recommends tacking to the stomach to be performed at the same time as long as veterinarian agrees. If said pet is neutered/spayed prior to 8 months of age the health guarantee is null and void.

All court costs, legal fees shall be paid by purchaser and all appearances, court, hearings shall be in the same city/state that the breeder resides in. No fee's shall be paid by Angie Killian.
